



## COLLABORATION AGREEMENT

# Gece Yarısı #4

This agreement records the terms under which the Artist and the Venue collaborate on the above artwork via milsiz. It supplements (and does not replace) milsiz's [platform Terms of Use](#), which govern the responsibilities of all parties.

## 1. TERMS

§1

## VENUE COMMISSION

**25%**

## PHYSICAL DISPLAY

## MINIMUM DURATION

30 days

## NOTICE PERIOD

14 days

## SHIPPING RESPONSIBILITY

Artist ships to the buyer

On any sale of an item under this agreement made through or at the Venue, the Venue shall receive **25%** of the sale price. This collaboration runs for a minimum of **30 days** from the

effective date; during that period it may only be ended by mutual agreement. After the minimum, either party may end the collaboration with **14 days'** written notice.

## 2. PHYSICAL DISPLAY

§2

Physical display at the Venue: **Yes**. Where physical display is enabled, the Venue agrees to display the artwork in good faith — visible to its patrons, in a manner consistent with the Venue's normal curation — for at least the minimum duration.

During transit, before the artwork has physically arrived at the Venue, the collaboration is live online: the Venue may include the artwork in its existing or newly-created online exhibitions on milsiz, market it to its audience, and accept early-interest signals. Sales completed during this window settle under the same commission terms as in §1.

## 3. WHAT'S COVERED

§3

No merchandise is consigned under this agreement — the collaboration covers the original artwork only.

## 4. LOGISTICS & SHIPPING

§4

When the artwork sells, the **Artist** arranges and dispatches shipping to the buyer. The Venue is not responsible for fulfilment.

### PLATFORM NOTE

milsiz acts as a technical intermediary, not as a party to the sale. The Artist remains the seller of record; the Venue is a curatorial host (and, where commission applies, a commissioned partner). Buyer protection, payments, and disputes are handled per milsiz's [Terms of Use](#).

## 5. PAYMENT & PAYOUT

§5

Sales are processed through milsiz. The Venue's commission is calculated automatically on each completed sale and is withheld at settlement. Payouts are issued to each party's connected payout account on the schedule defined by milsiz's payout policy.

## 6. TERMINATION

§6

Either party may request mutual termination at any time. After the minimum duration, either party may give **14 days'** notice to end the collaboration unilaterally. Upon termination, any consigned merchandise listed in §3 is returned to the Artist or settled per the parties' written agreement.
